WHAT TAKES PLACE DURING THIS STORY?

The story is set in Salem Village. Young Goodman Brown's wife, Faith, tells him that she feels scared when she is alone and doesn't want him to leave. Young Goodman Brown tells his wife Faith that he must travel for only one night. He tells her that if she says her prayers and goes to bed early, no harm will come to her.

Goodman Brown leaves thinking to himself that Faith might have guessed the evil purpose of his trip and his promise to be a better person after this night. Goodman Brown sets off on a road through a dreary forest. He is afraid of what might be lurking around every tree in the forest.

He comes across a man who greets him as though he knew he would be coming through the forest. The man looks like an ordinary guy except for the walking stick (staff) that he carries with a life like serpent carved in it.

The man offers his staff to Goodman Brown but he refuses. He tells the man that he showed up for their meeting because he promised to do so but doesn't want to touch the staff and wants to return to the village. Goodman Brown says that his family have been good people for generations and that he feels ashamed to associate with the man. The man tells Goodman Brown that he knew his father and grandfather, members of churches in New England, and the governor of the state.

The two come across an old woman struggling to walk through the forest. Goodman Brown recognizes her as Goody Cloyse who is known as a respected woman in the village. He is embarrassed for Goody Cloyse to see him with the man. Goody Cloyse identifies the man as the Devil and tells him that she is a witch on her way to the Devil's evil forest ceremony.

The man tells Goodman Brown that he should rest. He gives Goodman Brown his staff and tells him that he can use it for transport to the ceremony. After this, he disappears.

Soon he hears the voices of the minister of the church and Deacon Gookin, who are both on their way to the ceremony. Goodman Brown is shocked by this and says that although

Everyone else in the world has turned to the Devil, he will stay true to God for Faith's sake. Soon after this, he thinks he hears Faith's voice coming from the ceremony. He screams her name and a pink ribbon from her cap falls from the sky.

Goodman Brown grabs the staff and is pulled quickly towards the ceremony. The trees surrounding the ceremony are on fire and he sees the faces of various respected members of the community. He doesn't see Faith and hopes that she is not there.

A figure appears on a rock and tells the congregation to present the converts. Goodman Brown thinks he sees his father telling him to come forward and his mother trying to Hold him back. The minister and Deacon Gookin drag him forward. Goody Cloyse and Martha Carrier bring another person forward another person who is covered so that her identity is unknown.
